Saturday and Sunday June 15 – 16, 2019 8:00 am till 6:30 pm

### **Set up and take down times**

Move in Friday June 14, 2019 9:am till 11:00 am

Take down Sunday June 15, 2019 6:30 till 8:00 pm at the end of steeplechase and not before.

## **Event Rules**

- All booths should be manned for all the hours they are booked, up to and including Sunday at approximately 6:30 the end of Steeplechase final. Take down will not start until dogs are done competing.
- Booth Space – 10 by 10 Vendors are to supply their own table, chairs and shade tent. There will only be a grass space marked off for your booth. No electrical is available but you may bring your own small generator. No driving on the grass fields is allowed. You can stake your tent and we will try to provide space between booths for stakes.
- Retail Booth Space \$50.00 Payable to PACE. Double booth space \$100.00. Payable upon signing of agreement

## **Participation Waiver**

In consideration of the Performance Agility Club of Edmonton (“PACE”) permitting me to attend the 2019 AB/NWT AAC Regional Championships (the “Event”) as a vendor, I, the undersigned, agree as follows:

1. I agree that PACE may refuse my application to be a vendor for any reason it deems to be sufficient.

2. I understand and acknowledge that participation in the Event carries certain risks, including but not limited to injuries (including serious injuries and death) to myself, any dogs under my control or persons attending as my guests (my "Related Parties), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not sue Agility Association of Canada ("AAC"), PACE, the City of Leduc or any of the directors, executives, committees, representatives, employees, volunteers, sponsors or agents of AAC, PACE or the City of Leduc (the "Personnel") for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
3. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, PACE, the City of Leduc and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers' fees on a solicitor and own client basis) incurred by AAC, PACE, the City of Leduc or the Personnel that may arise due to:
  - a. any act or omission of myself, my Related Parties or any party for whom I am liable at law; or
  - b. aggressive behaviour by any dog under my control.
4. I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the "Rules"). I agree to abide by the Rules and to conduct myself and any dog under my control in accordance with the Rules. I understand that myself and/or any dog under my control may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.
5. I understand that AAC and/or PACE may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or PACE will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or PACE of my personal information.
6. I hereby grant to AAC and its affiliated companies, representatives, agents and assigns, all rights and permission to use or appropriate his/her and their dog's name, biography, likeness, photograph, voice, performing persona, or other indicia of identity broadcast, telecast, cablecast, transmission or distribution in any format or media known now or in the future.
7. Further, I hereby release AAC, and its affiliates, representatives, agents and assigns from any claim or cause of action for invasion of the rights of privacy, right of publicity, right of personality or any similar rights.
8. I have been given the opportunity to read and understand the terms of this Agreement before signing it, and have in fact done so. I understand that by signing this Agreement, I am restricting my legal rights and I sign this Agreement voluntarily and of my own free will.
